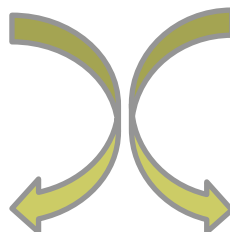

D-PPPs responsibility

- drafts legislation in the area of PPPs and pesticide residues
- **coordinates the process of registration and re-registration of PPPs between applicants and evaluators (from submission of the dossier to issuance of the authorization)**
- **carries out completeness check of application for registration of PPPs**
- **issues decisions on the authorisation of PPPs**
- prepares and coordinates programmes of post-authorisation control of PPPs (formulation monitoring)
- prepares and coordinates national monitoring programmes of pesticide residues in the products of plant origin
- maintains necessary evidences and registers relating to PPPs
- ...

CAFRA: Croatiaan Centre for Agriculture, Food and Rural Affairs - Plant Protection Institute (PPI)

- **Evaluation of dossiers and risk assessment, except the mammalian toxicology**
- **Laboratory analysis of physical-chemical properties in post-registration control of PPPs**

IMR - Institute for Medicinal Research and Occupational Health

- **Evaluation of dossiers and risk assessment of mammalian toxicology and operator exposure**



PPI & IMR

- **Preparation of proposals on authorisation PPPs (registration reports)**
- **Technical coordination of experts involved in dossier evaluation**
- **Preparation of expert opinions related to PPPs on MAFRD request**
- **Cooperation in drafting legislation and guidelines documents in the area of PPPs**

PPPs legislation



Croatia has transposed and implemented EU legislation

Necessary national legislation also has been adopted

EC accepted proposal of Croatia to start with gradual process of re-registration of „old“ PPPs authorized before implementation of EU legislation

Parallely, authorization holders, industry, associations and other interested public has been informed about new legislation and registration procedures through meetings, workshops, web, ...



Administrative staff and evaluators are trained by consecutive EU twinning projects (CARDS Twinning: 2002, 2004, IPA 2007)

Process of registration and re-reg according to UNIFORM PRINCIPLES has been started in 2008

To the July 2011 work on registration & re-reg was continuously supported by UK experts



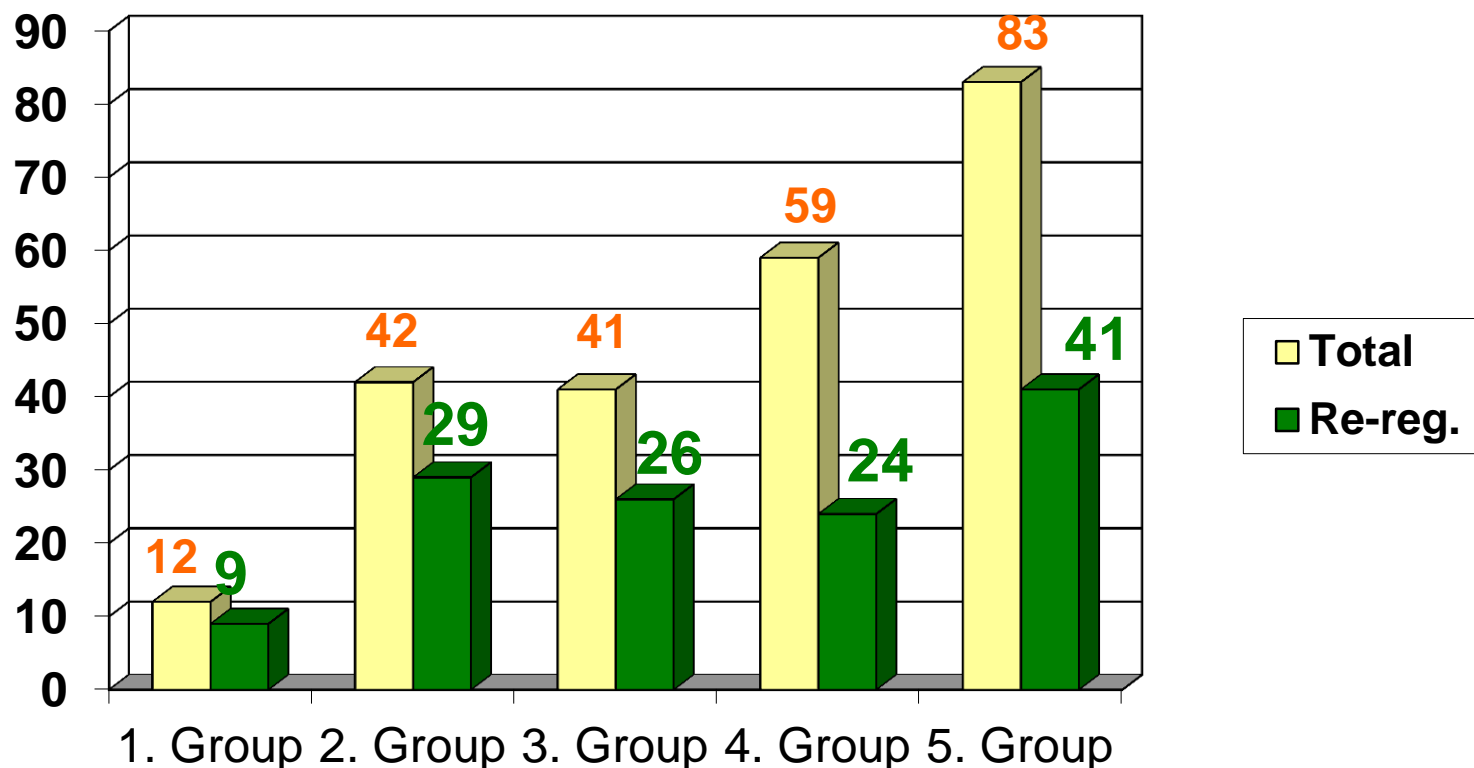
1st Program of re-registration of existing PPPs according to Uniform Principle

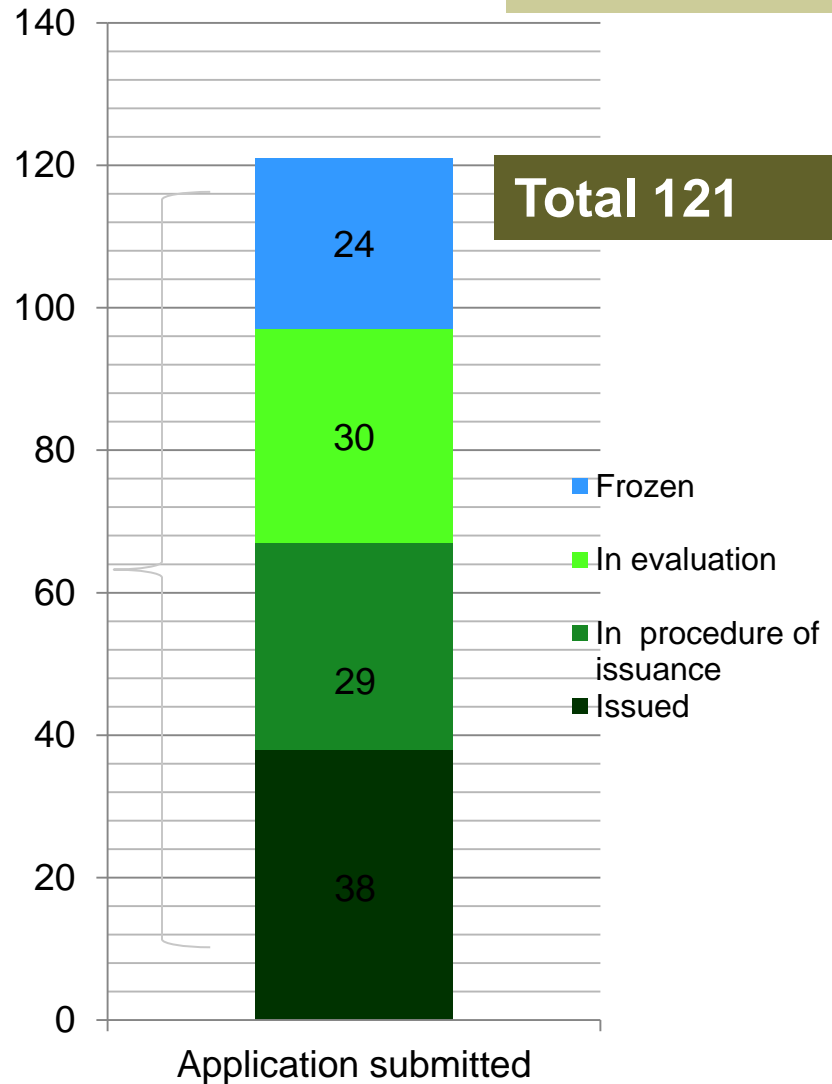
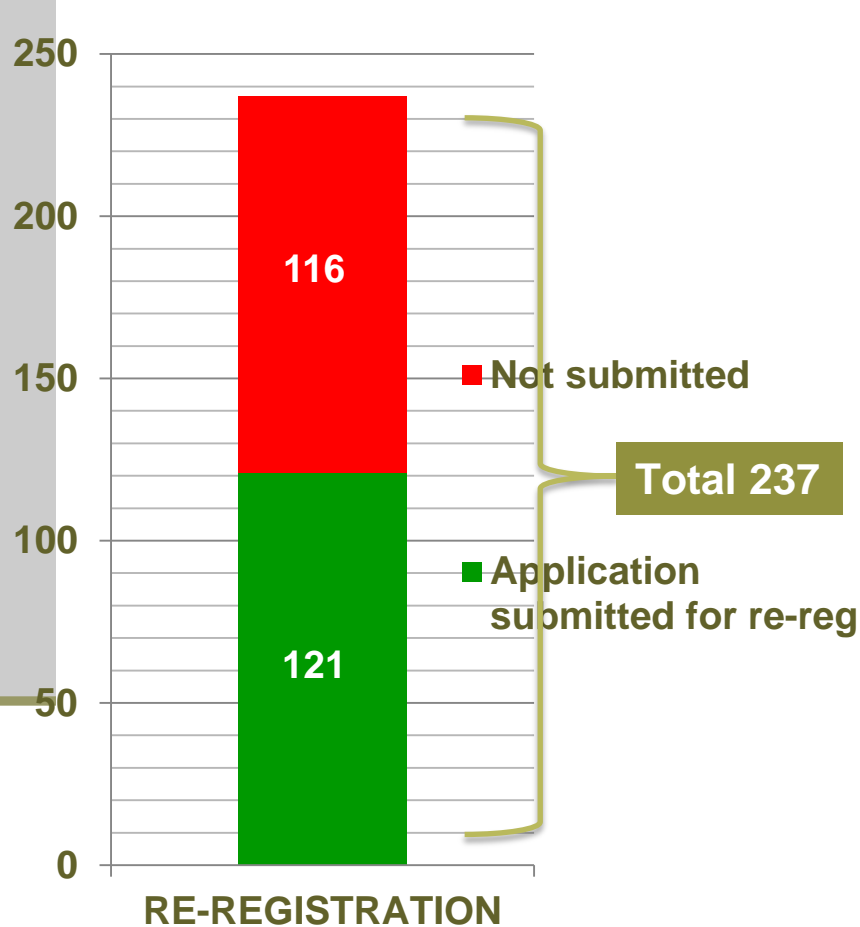


■ No of PPPs for re-registration supported by dossiers according to new legislation (Uniform Principles)

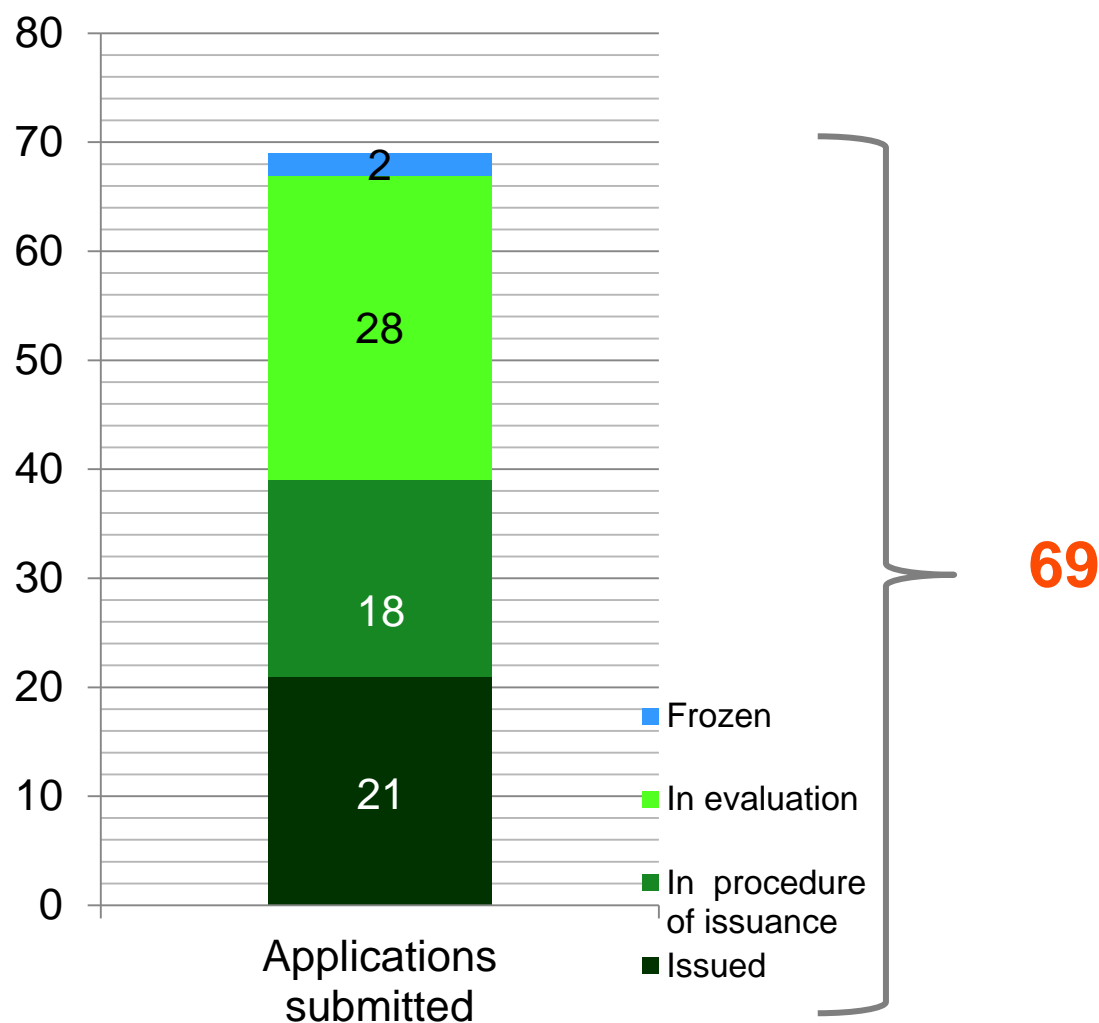
Revision of the Programme of re-registration

- According to existing Programme of re-registration - submission of the dossier was required in one step (Ax II & Ax III) because the aim was that Croatia reach deadline of the EU re-reg programme
- **New revised Programme:**
 - submission of the dossier for evaluation is planned to be in 2 steps
 - will comprise groups VI-VIII
- **Plan is that all PPPs authorized in Croatia are in compliance with EU Step 1 requirements to the date of Croatia's accession to EU**

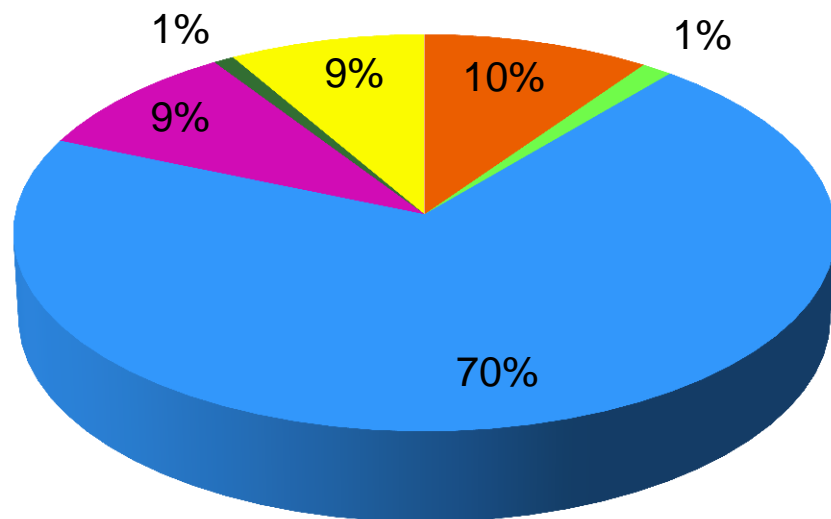
Submitted application for re-registration I-V group and their status



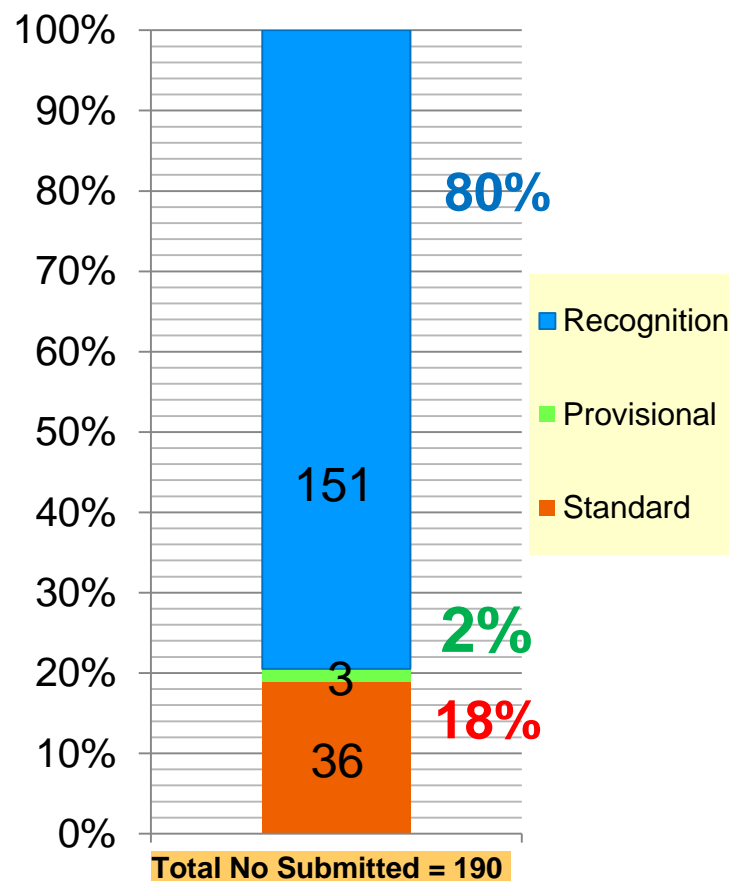
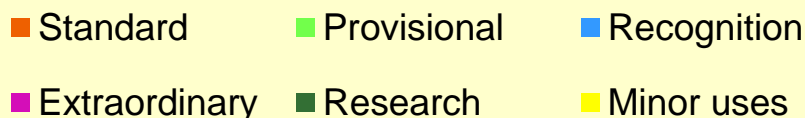
„New” application submitted for authorization according to Uniform Principles

Types of applications

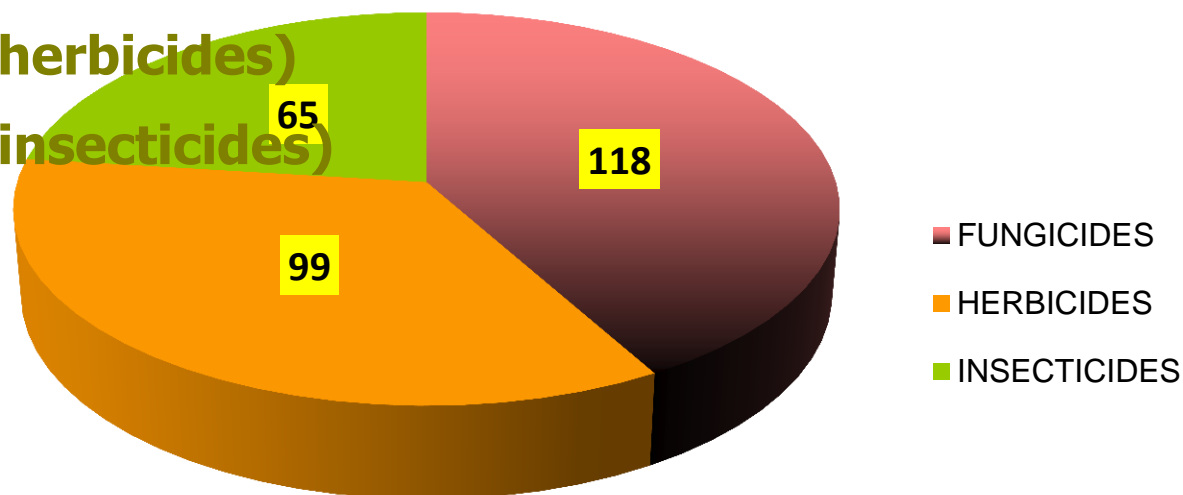


Extraordinary & Extension for Minor Uses

No. of authorizations extended for minor uses/ minor crops: 35

Total NEW USES: 282

- ✓ **118** new uses (fungicides)
- ✓ **99** new uses (herbicides)
- ✓ **65** new uses (insecticides)



Emergency situations: in 2011 till the October has been issued 22 extraordinary permits

New EU legislation



- **Within the IPA 2007 twinning project:**
- **New Regulation (EC) 1107/2009 was presented and explained to Croatian registration team by UK CRD-York experts and by Slovenian and Greece experts, who gave advices, proposals and their expectations relating to new provisions and requirements**
- **Sustainable Use Directive 2009/128/EC was presented in detail too**
- **Drafting of the Ordinance on sustainable use of pesticides was supported by UK experts**

Current tasks



- **New legislation:** drafting of SUD Ordinance is in final phase,
■ Draft will be published on MARD Web site for public to make comments
■ Drafting of NAP in 2012
- **New Information System** for PPPs & Residues is in phase of production – will serve as key tool to registration staff during the process of authorization, in preparation of monitoring programmes, in keeping of prescribed registers & evidences, as well as for information of stakeholders and all interested parties (stakeholders, industry, general public, ...)
- **Drafting of Programme of re-registration** procedure: new deadlines for groups VI-VIII will be determined by revised Program of re-registration (submission of the dossier in 2 steps)

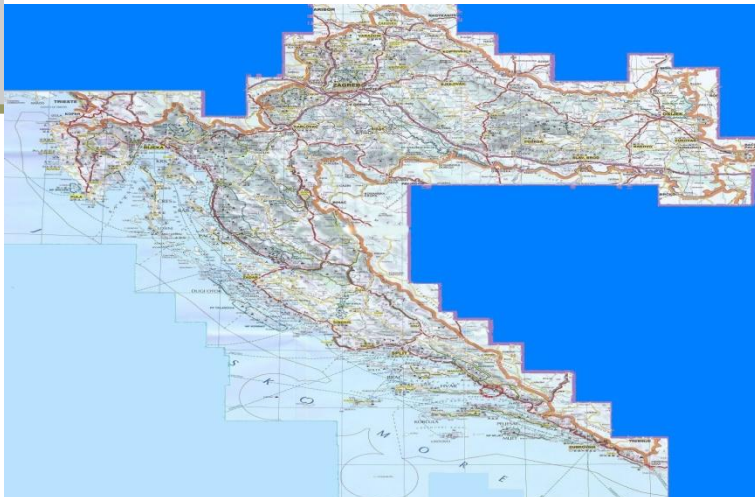


July, 2013 – Date of the accession of Republic of Croatia to EU

Regulation 1107/2009 & GDs will be directly applicable

New national legislation about the registration procedures and responsibilities is planned to be adopted to the end of 2012
