On behalf of the Hungarian National Food Chain Safety Office (NÉBIH) I would like to invite you to Budapest to participate in the CEUREG Forum XVII meeting.

The meeting is a technical conference for pesticide registration experts from Central and Eastern Europe. From the beginning till the past years the Forum has been organised by Hungary in Budapest in a close cooperation with the Czech Republic and Poland.

Since 2009 CEUREG Forum has been organised on rotational principle in Poland, Czech Republic, Slovakia, Austria and now again in Hungary.

The Forum provides an opportunity to exchange information and experiences between regulatory agencies in charge of placing plant protection products on the market in the Central and Eastern European Countries. European Commission is regularly represented on the Forum. The most important objective of the Forum activities is to help to reduce the risk of products used in the agriculture.

The main topics of the forum are as follows:

Hotel booking will be arranged by us, based on your registration.


If you want to stay longer, the hotel can offer the rooms for 88 € / single room and 98 € / double room for the further nights.
