PPPs Registration Authority



 According to Georgian Low on Pesticides and Agrochemicals Registration Authority is LEPL National Food Agency- Pesticides and Agrochemicals Division of Phytosanitary Department

In registration processes are involved:

- The Ministry of Environment Protection and Natural Resources of Georgia
- Ministry of Labor, Health and Social Affairs of Georgia
- Scientific-Research Institutes and Experts



LEPL – National Food Agency Phytosanitary Department Pesticides and Agrochemicals Division



According to The Statute of Agrochemicals and Pesticides Registration, Examination, Expertise Pesticides and Agrochemicals Division carry out

- Regulation of activities intended for registration process
- Pesticides registration examination coordination
- Management of the State Catalogue of Pesticides Permitted to Use in Georgia
- Issue registration certificates
- Elaboration of plant protection recommendations, effective and safe usage of pesticides
- Control of quality of pesticides
- Control of residues of pesticides in agriculture crops



Pesticides Registration Principle



Registration process is harmonized to Euro Union 91/414 ECC Directive, Annex I of the 91/414 ECC Directive

- Recognition Regime- checking dossier by Registering Authority, if the appropriate documentation is introduced to the EC countries similar to South-East climate zone of Georgia like Bulgaria, Hungary, Romania, Slovakia, Slovenia, Croatia (registration of the same crops and against the same harmful organisms upon the request of an applicant)
- On the basis of the Registering Authority checking dossier and the Scientific-Research Institutes carry out documentary expertise- if the appropriate documentation is introduced to the EU countries and OECD member states on the pesticide registration
- On the basis of the Registering Authority checking dossier and the Scientific-Research Institutes carry out documentary expertise and field examination if the appropriate documentation is introduced from the countries that doesn't belong neither to EU countries nor the OECD member States.



State Catalogue of Pesticides Permitted to use in Georgia



According to Georgian Legislation and International practice Catalogue represent the list of all pesticides permitted to use in Georgia

- Trade name of pesticide, active substances and concentration, registrant, state registration # and date, date of re registration
- Range of use (crops and harmful organisms), rates and time of application, number of treatment, pre harvest interval (waiting period)
- Hygienic standard (maximum residue level in agriculture products)
- Dangerous class of human health
- Ecological standard (limited allowable concentration in fish-producing water reservoirs)
- Dangerous class for bees and restriction



State Catalogue of Pesticides Permitted to Use in Georgia



- List of active substances
- List of pesticides
- List of pesticides which are prohibited to be imported before re registration
- Nowadays are registered 235 active substances and 600 preparative forms
