EU Regulation of our industry

- IBMA support regulation BUT in a proportionate manner to the risks posed
- Disproportionate regulation to the associated risks
- Always at the end of the queue
- Regulated under regulations that weren't designed for and don't fit our members' products
- Easy to cheat the system with false claims
- Unnecessary delays and timelines
- Lack of predictability
- Lack of consistency and harmonisation
- Costing our whole industry disproportionately



Favourable initiatives in EU Regulation

- General Policy
 - Blessing or Curse is in favour
- Sustainable Uses Directive
 - Good intention to favour alternatives and IPM
 - In practice NAPs offer little hope
- Establishment of expert & working groups
- 1107/2009 Priority for low-risk substances
 - The obvious opportunity for our industry
 - A winning objective to all

 - Farmer Groups esp. Copa-Cogeca and National Groups






Areas of possible concern for IBMA

Perceived obstacles to increased use of biocontrol in IPM systems as a part of sustainable agriculture

- Lack of resistance
- Lack of priority
- Lack of resources
- Lack of guidance
- Lack of harmonisation
- Lack of appropriate expertise
- Unclear terminology
- Lack of foreseen benefit
- A flawed approach to empty the toolbox first and delay filling it!
- The very fact that biological options are in general considered safer!

- Continue working on improved guidance
- Work on appropriate tests to address the real risks
- Make solving the problems all stakeholders priority
 - Why is this the regulators priority?
- Education and dissemination
- Harmonisation at all levels

- Create and use perception wisely




Ensuring biocontrol is a major part of EU sustainable agriculture

- Seek amendments to legislation to bring low-risk products to market quicker




Timelines 1107/2009


