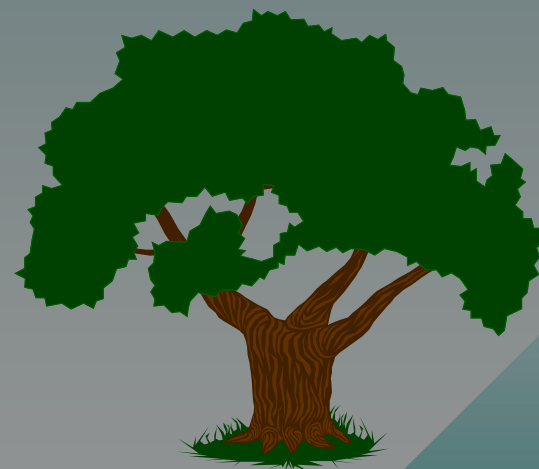

# **Codecision Procedure (1)** **(Article 251 of the EC Treaty)**

**JOINT DECLARATION** (of the European Parliament, the Council and the Commission) **ON PRACTICAL ARRANGEMENTS FOR THE CODECISION PROCEDURE**

Cooperation between these three EU institutions in the context of **codecision** often takes the form of **tripartite meetings** (hereinafter '**trilogues**').

# **Codecision Procedure (2)**

## **(Article 251 of the EC Treaty)**

As the **codecision procedure in trilogues is very complicated** (parallel work in the institutions, three phases, three readings) for better understanding there was developed

- containing 6 Annexes

**10/10/2016 - Council of the European Union - Council of the Ministers of Agriculture of the EU MSs  
- formal acceptance of political agreement**

## **Next steps**

**08/11/2016 - legal and linguistic finalization of the text**

**xx/11/2016 - European Parliament - to adopt text in the 1st reading ?**

**31/12/2016 - publication in the EU Official Journal?**

**Entry into force - 2017 ? Shall apply + 3 year - 2020 ?!!**
