OTHER IMPORTANT INFORMATION

Please note:

- travelling and accommodation expenses are not covered by the organizer
- as the program begins on Monday morning, it is suggested to arrive to Budapest on Sunday, 13 October 2019
- all delegates are invited for lunch on both days and dinner on the 1st day
- delegates from the national PPPs registration authorities or other official bodies and invited speakers do not pay any registration fee
- delegates **not representing authorities and not invited as speakers** are asked to pay a **registration fee of 190 € (or from Hungarian address 62.000 HUF)** for the purpose of covering their expenses concerning the conference
- the working language of the conference is English, no translation is provided

If you are not representing authority or official body and you are not invited speaker, please transfer the registration fee till 30 September 2019 to the following account of NÉBIH, belonging to Hungarian State Treasury:
