## **Experiences with the zonal process**


- Agreed procedures, responsibilities, reporting (Registration Report), and language (English)
  - Creation of the registration report is more time consuming than expected
  - The complete zonal evaluation has to be done by the zRMS
  - The interpretation of the Reg. 1107/2009 deviates between MS
  - Assessment and decision criteria are not fully harmonised
  - Decision criteria are sometimes based on national data requirements
  - Risk migitation measures are not harmonised
- Ideally, assessment and decision criteria would be harmonised

## **Experiences with the zonal process**

- Not harmonised procedures cause problems
  - High workload in the MS
  - The number of court cases in DE increases
  - DE was sentenced to accept the decisions of other MS
  - When DE is cMS, only Art. 36 (3) is allowed for rejection
  - Even if no complete dRR/RR (legal/administrative requirements) is available, DE has to take over the evaluation of the zRMS
- $\rightarrow$  Unequal authorisations  $\rightarrow$  Unequal ppp availability in MS
- $\rightarrow$  Unequal situation for users in contrast to the basic idea of the EU





## Harmonisation

# Harmonisation is important in the zonal process of Reg. 1107/2009

- Coordination and cooperation between the national authorities in the Member States
  - Three Zonal Steering Committees
  - Inter-Zonal Steering Committee
  - Directors Consultation Group (DCG) in the central zone
  - Post-Approval Issues group (EU-COM)
- Further tools for harmonisation
  - Development of EU Guidance Documents
  - Expert Meetings and Expert Groups (CIRCABC)

## The process of harmonisation is very important but time consuming and leads to a high workload





## **Central Zone Steering Committee (CZSC)**

- Guidance document on zonal evaluation and mutual recognition SANCO/13169/2010
- CZSC established in 2010
- Five telephone conferences and one "face to face meeting" per year
- Promotion of harmonisation and cooperation by work sharing
- Information of applicants via CIRCABC and annual "face to face" meetings

## **Director's Consultation Group (DCG)**

- Exchange on director's level
- DCG established in 2014
- Min. two telephone conferences and one "face to face meeting" per year





## The CZSC secretariat

- Problem: The administrative burden for the chair has grown
  - Lack of resources not only in small MS

#### Solution: Secretarial support

- Chairmanship: rotates annually
- Secretariat: DE and NL: consistent responsibility
- Administrative support in consultation with the chair
- Each member state can more easily take up the role of chair both for the CZSC and DCG
- Secretariat established in 2017
- Positive Feedback from MS and applicants
  - DCG decided on continuation until 2023



- Publication of agreements of the CZSC in the format of "Bullet points" in the public part of CIRCABC

- PAI and IZSC secretariat
  - PAI and IZSC meetings are organised by the EU Commission
  - The chairs of the 3 zonal steering committees provide a summary of their recent meeting(s)
  - The secretariat is run by DE with support by AT and was established in June 2017

## **Current activities**

## DCG

#### • Meeting of DCG with NZ, SZ, COM and EFSA

- Goal: improve the communication between MS, EFSA and COM
- Next steps for further meetings between the MS of all three zones, EFSA and COM are under discussion
- RMM in ppp authorisation and active substance approval:
  - The DCG works on a proposal to implement risk mitigation measures in the active substance approval process

#### • Proposal from DCG to COM:

 Make available the final version of the GD on Zonal Evaluation and Mutual Recognition as "noted by Standing Committee and agreed for formal adoption and publication as a Notice by the Commission. It should be used in the meantime from [date]".



## CZSC

- Worksharing: Allocation of zRMS for Art. 43 applications after renewal of AIR 4 batches
- AIR 4 group 1-3:
  - Secretariat informed applicants in May 2019 about allocated zRMS
- AIR 4 group 4:
  - Approvals prolonged (31.07.2021 to 31.12.2024)
  - Allocation of zRMS will be started in spring 2021



## CZSC

- Interzonal assessment of protected crops
  - Background: some areas of the risk assessment are not harmonised
- Goal: harmonise and clarify the risk assessment under protected conditions for all three regulatory zones
  - GD on protected crops (EFSA Journal 2014;12(3):3615)
  - Questionnaire on MS's practices in assessment of protected crops
  - Initiation of a working group by DE
  - Other zones will be informed and existing guidance and ongoing projects from the other zones will be taken into account.



## CZSC

- Assessment of non-professional uses
  - Background: differences between MS of great note for applicants
  - Questionnaire summarised by PL
- Goal: provide information on harmonized procedures
  - Bullet point under discussion
- Goal: provide information on non-harmonized procedures
  - Update of the table "National Requirements" on CIRCABC



CZSC

#### • BREXIT

- UK accepts only national applications or as cMS. UK attempts to complete all open zonal applications as zRMS before 10/2019. For the remaining applications fall-back zRMS are allocated.
- MS accept a shortened commenting period of 3 weeks for Art.
  29/33 applications so that UK can still complete the applications.
- UK remains a member of the EPPO zone and efficacy studies from the UK are accepted (as required by EPPO standards, GEP compliance and culture requirements)



## DCG

- At European level, a forum to address issues at a strategic level is needed.
  - Agreements within zones: existing Committees are fit for purpose
  - No structures for rapid exchange/agreements at a strategic level
  - All three European zones need to be brought together
  - Currently discussed: NZ and SZ could be invited to join the DCG
  - $\rightarrow$  "European Director's summit"



## Summary

- The process of harmonisation is time consuming and leads to a high workload
- The efforts of the Members States in the differed groups lead towards harmonisation
- The CZSC secretariat successfully reduces the burden of the chair of the CZSC
- At European level, a forum to address issues at a strategic level is needed
